A new application has been added to the KHEDS program inventory tab to support the articulation of military training and the associated approval workflow. The data will drive the statewide website housed by KBOR. This workshop will explore the functionality of the application and provide best practices on how to enter articulations.

Workshop: Credential Engine

This workshop will provide an overview of Credential Engine's Credential Finder and how our public institutions' program inventory data will be presented. The goal of the workshop is to allow users to become familiar with the website, so they can review the data being shared and provide feedback.

Workshop: KHEStats – Transfer Feedback

The Kansas Board of Regents recently developed an interactive Transfer reporting tab in the Kansas Higher Education Statistics online reporting tool. This tool can be used to compare the credits and grade point averages of students as transferred upon entry with those of credits and GPAs earned during the fall term at the receiving institution. This interactive workshop will offer participants a chance to learn about the tab and its available reports, all of which rely upon data from the Kansas Higher Education Data System (KHEDS).

Workshop: KHEStats – Fall Census

A tab on the Kansas Higher Education Statistics online reporting tool, the KHEER tab refers to data contained in the Kansas Higher Education Enrollment Report. Currently, the tab is under redesign and will account for the changes made for the Fall Census and Fall Prelim counts. During this session, members of the Reporting Team will discuss the changes and its redesign plans.

Workshop: Workforce Development Forum

This session will provide institutions an opportunity to ask questions and receive one-on-one technical assistance with KBOR Workforce Development staff. Topics of interest may include but are not limited to: KHEDS, Perkins, PABLO, AO-K, AO-K @ Work (Walmart grant), AO-K to Work (SB199), or GED. The session will have an open format.

Workshop: Newcomer Training – New Employees (in the job one year or less)

During this workshop Kansas Board of Regents' staff will focus on introducing new staff to the Kansas Higher Education Data System (KHEDS). The basics of the different data collections will be discussed as well as how the collections are related and how the data is used. The session will include a demonstration on navigating the DRP authenticated website. Attendees are encouraged to bring their laptops to follow along with the presentation.
