KAN-ED AWARDS MEMBER ORGANIZATIONS GRANTS TOTALING OVER \$2 MILLION

Technology Upgrades and Enhancement Projects Assist Kansas Hospitals, Schools, and Libraries

(TOPEKA) – Today Kan-ed, a statewide information network administered by the Board of Regents, named 94 organizations as recipients of Equipment and Technology Grants.

"The grant awards provide Kan-ed members with a tremendous opportunity to obtain the latest technology and equipment available in order to enhance video conferencing services," said Brad Williams, Executive Director of Kan-ed. "This funding will have direct and positive impacts on the lives of Kansans across the state, as advanced video conferencing technology enables organizations to better serve their communities. Members are bringing together K-12 learning partners around the world, allowing patients to coordinate healthcare needs with providers separated by geography, and facilitating research partnerships at universities. The ability to identify critical member needs and offer opportunities to enhance access through technology contributes to the continued growth of Kan-ed."

Through this grant program, created in 2004, Kan-ed distributed \$2.1 million in 2008 to its members for upgrades or enhancement of video conference equipment. Any connected Kan-ed member, or member that agreed to connect to the network, was eligible to apply for funding. Currently, Kan-ed has 834 members, with 288 members connected to the network for high-speed access to resources and programs. This program is funded by state appropriations, revenue generated through the E-rate program, and federal sources.

Kan-ed reviewed the 139 proposals that were submitted and granted awards to 94 organizations. Priority consideration was given to proposals that focused on meeting infrastructure development goals and objectives for the Kan-ed network and members. The following table outlines the organizations and award amounts.

The nine-member Kansas Board of Regents is the governing board of the state's six universities and the statewide coordinating board for the state's 32 public higher education institutions (six state universities, a municipal university, nineteen community colleges, and six technical colleges). In addition, the Board administers the state's student financial aid, adult education, GED, and career and technical education programs. The Board also authorizes private proprietary schools and out-of-state institutions to operate in Kansas, and administers the Kan-ed network, a statewide network that provides broadband Internet access and distance learning capabilities for schools, hospitals, and libraries.

Kan-ed, a program administered through the Kansas Board of Regents, is designed to give Kansans a competitive advantage in the global marketplace by connecting the state's hospitals, libraries, higher education institutions, and K-12 public and private schools with high-speed bandwidth to bring members together through Interactive Distance Learning and the exchange of data. Kan-ed membership benefits include shared databases, video-conferencing, telemedicine, and content otherwise unavailable or available at costs too prohibitive for most schools, libraries and hospitals.
