A. From the 12/4/24 minutes:

**UHC SR Quarterly Reports**

For PY 24-25, there is data for four months. Enrollment the past few years has been dropping; PY 22-23 had 6,112 students. PY 24-25 has 5,510 students, based on estimated annualized count. That is the lowest enrollment in the past four PYs. The data also reflects shifting in age to a slightly older population than in the past. Carol Solko-Olliff asked if that data reflects more graduate students in the upper age ranges, and Jim Lester responded he will get information about the undergraduate and graduate age breakdowns. 1/10/25 email from Ellison: Attached is the age group breakdown.

**Newborns**

Morgan Swartzlander asked why the liveborn is considered a dependent. Jim Lester responded even if the child only has coverage for the first 31 days, the child has an independent identifier code. He will get information about how dependents are being identified. 1/10/25 email from Ellison: When we get a dependent claim, they claim number is identified as 1234567-3, which identifies the claim as a “Dependent Child” claim. -1 is for Students, -2 is for Spouse. See below as an example:

**Items from September 4, 2024, SIAC meeting**

1. Jennifer Williams, KSU, asked if UHC SR could increase the number of days the payment link is available for Option 3 students as they often have to wait for funds to be available. The graduate students would like the link to be active throughout the enrollment period, which is most likely not feasible, but an extension from the current five-day window would be appreciated. Matt Brinson replied that he will discuss this with UHC SR’s Partner Center team to see if the period can be extended beyond five days. [After the meeting, Jim Lester provided the following response: It was confirmed that the payment link is open for the period for which the link was sent. So, for example, for the Fall, the link would be good until the cutoff date, which would have been 10/1/24. If the issue is monthly, that link is set to expire 5 days after the date for which it is issued. Given the short coverage period for monthly, that length of time is unfortunately not something that can be changed.]

Several SIAC members noted that the link is only available for five days even for those Option 3 students and not until the enrollment period expires. Jim Lester will follow-up with UHC SR contacts. 1/10/25 email from Ellison: We have confirmed that we cannot extend beyond the 5-day calendar link.

B. From the 12/20/24 draft minutes:

**Good of the Order**

1. Carol Solko-Olliff asked if UHC SR could provide a report on claims denied at the February Committee meeting. Ellison Rooney said a campus-by-campus report can be provided. 1/13/25 email from Ellison: We have received the denied claim reporting but are unable to share it in any written format due to corporate policy. We can share this information verbally (at the next SIAC meeting).
2. Aaron Coffey said he heard from a student who received an email from UHC SR about "Proofpoint," a secure email platform. He asked that UHC SR share information about this before the students see it. Ellison Rooney said this platform will replace the previous Cisco platform. She will reach out to the transition team. 1/10/25 email from Ellison: UHCSR is moving to a new Secure Email solution and their plan to have it completed by April 2025. Secure email recipients will experience the following changes: The first time recipients receive a secure message, they will be required to register with Proofpoint. The experience will be similar to the process for registering with Cisco. I've attached the external recipient user guide for a little more information.

**MINUTES**  
 December 20, 2024

The December 20, 2024, meeting of the Student Insurance Advisory Committee (SIAC) was called to order at 12:30 p.m.

Also participating were Ellison Rooney, UHC SR; and John Yeary, Gage Rohlf, Becky Pottebaum, and Kristin Scruggs, KBOR. Kiera Pulliam, PSU, and Jonah Sandford, PSU student, were unable to attend.

**Minutes**

Matt Anderson moved to approve the December 4, 2024, minutes. Following the second by Jennifer Williams, the motion carried.

**Plan Year 25-26 Renewal – Revised Information**

At the SIAC’s December 4, 2024, meeting, the Committee reviewed UHC SR’s initial renewal information that reflected no premium increase but some enhanced benefits for Options 2, 3 and 4 (changed the Preferred Provider OOP maximum from \$8,200 to \$8,000 (Family max of \$16,000); changed the Rx Tier 2 coinsurance from 40% to 30%; and changed the Deductible from \$500 to \$450).

After discussion, the Committee members expressed interest in receiving revised renewal information reflecting a premium decrease and the potential for changing the Rx Tier 2 coinsurance from 40% to 30%. UHC SR’s revised PY 25-26 renewal information was emailed to SIAC members on December 11, 2024.

SIAC members shared information about their university sub-committee preferences. The following shared that their sub-committees preferred the option with the 6% premium decrease duplicating existing benefits: Tabatha Tafoya, ESU; Carol Solko-Olliff, FHSU; and Matt Anderson, KUMC. Morgan Swartzlander reported that KU’s sub-committee was split but favored the smaller premium decrease with the reduction in Tier 2 prescription coinsurance. However, Ms. Swartzlander supports approval of the larger premium decrease.

Aaron Coffey reported that WSU's committee was concerned about a "yo-yo" resulting from a premium reduction this year being followed by a larger increase in a subsequent year and would vote to leave premiums at the current level. However, between the two new options, WSU's committee would opt for the larger premium decrease.

Jennifer Williams asked whether there would be a yo-yo after decreasing premiums this year, given the changes made regarding dependent coverage for Option 1. Jeff Dewitt noted that the recent larger increase was due to extraordinary claims, but that claims are more consistent following the structural change. Ellison Rooney agreed, but noted there is still a chance of large claims that could necessitate an increase.

After hearing input from the Committee members, Jeff Dewitt summarized the collective viewpoint that, following the plans' structural change and good plan experience, it is time to give some of the profit reaped by the insurer back to the students in the form of lower premiums, and that the group's consensus was to opt for the maximum premium decrease. Ellison Rooney said that UHC SR will be happy to do this and appreciates the Committee's feedback.

Aaron Coffey moved to recommend the across-the-board 6% premium decrease duplicating existing benefits for Plan Year 25-26. Carol Solko-Olliff seconded the motion. The motion carried.

Jeff DeWitt, who was unable to attend the December 4 meeting, said that he had reviewed the meeting minutes. He thanked the Committee on behalf of himself and the student population for the Committee's thoughtfulness and insightful questions.

Jeff DeWitt will shepherd the SIAC recommendation through the various KBOR committees. If approved by the Council of Business Officers at its January 8, 2025, meeting, the recommendation will be taken to the Council of Presidents at its January 15, 2025, meeting. If approved, the recommendation will be presented to the Governance Committee and the Board of Regents at their February 12, 2025, meetings.

Overview of January 2025 Process (Ongoing)**

Date of Report: January 15, 2025

At the request of the Kansas Board of Regents (KBOR) this document serves as an overview of the work ECI has performed for six of the seven KBOR schools: (1) University of Kansas (KU), (2) University of Kansas Medical Center (KUMC), (3) Kansas State University (KSU), (4) Emporia State University (ESU), (5) Wichita State University (WSU), and (6) Pittsburg State University (PSU).

The waiver/enrollment processes have proceeded normally for audits, enrollment if applicable, and Customer Service.

Attached are the Spring 2025 Elev834 reports with to-date results on waiver and enrollment data for the semester, and Customer Service and Ticket reports. ECI expects to end work for Spring 2025 by early February, with one school finalizing their waivers in early March. We've noticed an increase in the number of "preaudits" requested from students prior to them submitting a waiver. Hopefully, that's helped them not to spend money on a policy that would not pass an audit. Such actions reflects to ECI that students are being thoughtful about the waiver process.

ECI does not report on monthly enrollments, special handling, or dependent enrollment.

STUDENTS WITH DENIED WAIVERS AND ACTIVE/DROPPED/DENIED WAIVERS - PENDING ENROLLMENT	Student that has an approved waiver on file, but subsequently enrolls on SHIP*, but student is not yet Active on carrier's system.
